The Board of School Trustees of the Rensselaer Central Schools Corporation met in Regular Session on Tuesday, January 16, 2024 at the Rensselaer Central Schools Corporation Administrative Offices Board Conference Room. Board Members present were Janice Deno, Cole Buschman, Gary Braasch, Courtney Wilcox, Emily Lyons, and Nancy Souza. Mark Jordan was absent.

President Braasch called the meeting to order at 7:00 p.m.

President Braasch determined a quorum present.

The Pledge of Allegiance was recited by all.

President Braasch stated that there was one (1) addition. Item H.1 Building and Grounds – Presentation by Ernie Watson. Mrs. Wilcox made a motion to approve the amended agenda. Mrs. Deno seconded the motion and the vote of the board was unanimous in favor of the motion.
