REGULAR SESSION

The Board of School Trustees of the Rensselaer Central Schools Corporation met in Regular Session on Tuesday, April 18, 2023 at the Rensselaer Central Schools Corporation Administrative Offices Board Conference Room. Board Members present were Janice Deno, Charlie Parrish, Gary Braasch, Kevin Arnold, Rick Odle, and Mark Jordan. Emily Lyons was absent.

President Braasch called the meeting to order at 7:00 p.m.

President Braasch determined a quorum present.

The Pledge of Allegiance was recited by all.

President Braasch stated that there were (3) additions to the agenda, Item J.9 – Approval to Receive Quotes for High School Food Service Upgrades. K.1 – Additional Teacher Resignation – Jared Coller – Band Teacher. Item K.3 – Remove Volleyball Coaches Katie Bilyeu and Kim Gilbert from Approval at this time. Mr. Odle made a motion to approve the amended agenda. Mr. Parrish seconded the motion and the vote of the board was unanimous in favor of the motion.

The minutes of the March 21, 2023 Regular Session Meeting were presented for board approval. Mr. Jordan made the motion to approve the minutes. Mrs. Deno seconded the motion and the vote of the board was unanimous in favor of the motion.

President Braasch asked for comments from the RCCTA. Michelle Carrera wished to thank those who contacted Senators and Representatives about the House Bill 1004 and the needed funds for public education.

President Braasch asked for patron comments. Kathy Staddon expressed her concerns regarding the Lifewise Academy. Mark Hurley and Brock Hurley spoke regarding the reduction to one Ag Teacher. Marissa Marlin spoke on behalf of her support for Lifewise Academy.

President Braasch asked for Board comments. Janice Deno commended the Math Bowl Teachers: Ms. Yentes, Mr. Webb and Ms. Schiavone. The team competed last week and did very good. The band placed Gold at their competition in Kankakee, congratulations to Mr. Coller. The play did excellent on all four presentations with the band playing for the musical as well. She thanked Mr. Sell and Mr. Coller for a great job with The Addam's Family.

Superintendent Craig updated the board on several projects planned corporation wide.

- Chiller is scheduled for start up on April 26th and 27th
- Meeting on April 25th with the roofing contractor for the High School
- Meeting on April 21st with the Architect for the restroom/concession facility

Claims dated April 18, 2023 were presented for board approval. Mrs. Deno made the motion to approve the claims. Mr. Parrish seconded the motion and the vote of the board was unanimous in favor of the motion.

Superintendent Craig requested board approval for an Increase from Three Periods to Four Periods of Instruction Time for Walt Brown for 2023-2024. Mr. Odle made the motion to approve the request. Mr. Arnold seconded the motion and the vote of the board was unanimous in favor of the motion.

Superintendent Craig requested board approval for Grade 3-5 Students to be Released to Lifewise Academy for Religious Instruction. Mrs. Deno made the motion to table the request.
